




1. **Name of the Society** : The name of the Society will be :-

change.


3. **Area of Operation** : All over Jharkhand

4. **AIMS AND OBJECT** :

1. To implement the Centrally Sponsored Scheme "Skill Development Initiative" or its successor scheme, by whatever name that would be described.
2. To implement any other Centrally Sponsored or State Scheme for the Skill Development in people.
3. To promote and carry out, on its own or on behalf of the State Government, activities to generate awareness, research and study on the issues relating to Skill Development, Especially school drop outs, rescued, child labour and all other disadvantaged groups.
4. To undertake the capacity building and training of the stakeholder, including vocational training providers, the State officials and Industry.
5. To enter into any agreement with any person, company or association having similar objects.
6. To register vocational training providers in uncovered areas particularly rural and backward areas and to provide necessary funds to them.
7. To do all such other things as may be necessary, ancillary, incidental or conducive to the attainment of all or any of the objects of the society.
8. In pursuance of the above objects, the functions or the Society to be undertaken directly by the Society officers or staff or sponsored / Supported by it through other institutions, agencies or individuals will be as follows: To undertake all activities that may be necessary for the implementation of the






schemes undertaken by it and in particular for the achievement of the objects referred to in Article 3 above.

9. To create duly empowered administrative mechanisms through such participation as may deemed necessary, for the achievement of the objects of the Society.
10. To establish for the implementation of the schemes, Task Forces, at State and ITI levels, as the case may be and to delegate necessary powers of enable them to discharge their responsibilities.
11. To secure active involvement and participation of academic and training institutes, trade unions and local government bodies.
12. To empower the VTPs through the process of organizing training awareness building and other appropriate mechanism.
13. To undertake experimentation and innovation in the areas of skill development as well as labor security and safety.
14. To obtain technical Employment and Training support by networking with the existing national and State level institutions or through establishment or new ones.
15. To advise the State Government in implementation of Skill Development measures.
16. To insure employment, setting up consultancies, security agencies and playing role as channel between job providers and job seekers.
17. To arrange, production and supply of appropriate materials like stationary, goods, machinery, human resource etc. for development works run by block, district, state and central authorities.
18. To purchase, hire, take on lease exchange or otherwise acquire property movable or immovable and to construct, alter and maintain any building or buildings as may be necessary for carrying out the objects of the Society.
19. To work for Right to information, Right to education, Right to service, Food security and other acts and laws of government.
20. To promote, higher and technical education in both urban and rural area. Technical education like typing, computer training and establish regular school, library, night school, adult education and with other specialties.
21. To provide, legal awareness, and legal aid to the poors, women, children and deprived class of the society. Promote Right awareness. Keep away from blind faith and aware them on scientific education.
22. To empower the women, society will provide training like beautician, tailoring, swing, painting, soft toys making, jam, pickles, sauces, candle, agarbatti etc.
23. To do all measures, to promote, flourish all types of animal husbandry and dairy business .






24. To establish new schools i.e - play, nursery, primary, middle schools; colleges and universities based on different streams, modes, patterns, methods, specifications etc.

RULES AND REGULATION

OF

'IMPACT INDIA FOUNDATION'

1. **Definition:-**

- (i) Society Name :- 'IMPACT INDIA FOUNDATION'  
(ii) Committee Name :- Executive body of the society.  
(iii) Financial Years Means :- 1<sup>st</sup> April to 31<sup>st</sup> March  
(iv) General body means :- Body of ordinary members of the Society  
(v) Act means :- Society Registration Act. 21 of 1860  
(vi) Office Bearers means :- Members appointed by executive body to the post of the society.  
(vii) Executive Body means :- President, Vice-President, Secretary, Joint-Secretary and Treasurer

2. **Condition for the membership of society:-**

**Eligibility:**


Any citizen of India who has attained the age of eighteen years may become a members of the society, irrespective of caste, creed and gender and who is competent to enter into a Contract under the Indian Contract Act. A new member will be admitted only after the resolution of the general body.


**Subscription :-**


The admission fee as the Member of the society will be a sum of rupees Five hundred only. The monthly subscription will be Rs. 200/-.

**Admission by Resolution :-**

For Admitting a person, his name be put before the Governing Body and admit him as Member by taking Resolutions only after the consent of the secretary. Failure to deposit subscription: - The persons/ members whose subscription at any time will have been in arrears for a period exceeding six months will not be entitled to vote or and will not be eligible for monition to be elected as office bearers of the Governing Body.

3. Termination of membership of society:-

Any member of the society may be expelled from the society and his membership may be terminated by a resolution of the general body passed with a simple majority or in following situations:-

- (i) By self resignation
- (ii) Mental disorder, death or bankruptcy
- (iii) Non-payment of subscription or invoices for goods or services
- (iv) Found guilty by court/ society.

4. Composition of Executive body :-

There will be seven executive members including office bearers whose term in office will be of three Years. They will be elected by the general body.

5. Power and functions of Executive body:-


- (i) To take appropriate steps to achieve the objective of the society.
- (ii) To elect president, and other office bearer of the society.


6. Power and functions of the office bears :-


(I) PRESIDENT :

The powers, functions and duties of the president will be as follows:

- (a) The President will be the honorary head of the 'IMPACT INDIA FOUNDATION'.
- (b) To preside over the meetings of general body, and executive body, and other important meetings.
- (c) He will have power to convene ordinary and extra-ordinary meeting.
- (d) He will have the right of casting vote in case of division.
- (e) The take care of the Society's activities.
- (f) The president will initiate action for identification and mobilization of resource needed for conducting training program /course.
- (g) The president will initiate action for planning of programs such as preparation of course designs, teaching /learning material, procedure for learning assessment , program schedule , selection and enrolment of participants timing and location for conduction of program.
- (h) The president will establish and develop contracts with appropriate agencies with a view to facilitate exchange of information and promoting mutually

beneficial lineage in programs and activities to be organized for target groups by foundation itself or its joint ventures in operation/collaboration.


- (i) The president will render and facilitate consultation and counseling services to individuals and agencies Institute in matters of technical and management training program.


(II) VICE- PRESIDENT :


The President will be vested of all the powers of the President in the absence of the President, else will be guided by the president for his works as delegated by the President.

(III) SECRETARY:-

- (a) The Secretary of 'IMPACT INDIA FOUNDATION' will be the chief executive officer of the Council of promoters. The Secretary supervision and discipline any control as may be necessary under rules.
- (b) The Secretary will maintain a record of the minutes of all the meetings of the Council of promoters and will be responsible for the proper execution and implementation of the decisions of the Council of Promoters.
- (c) The Secretary will be the drawing and disbursing officer.
- (d) The Secretary will take decision for appointment and termination of member office bearers or employees on behalf of the society.
- (e) The Secretary will pursue action connected with follow up conclusion and recommendation of seminars/ workshops etc.
- (f) The Secretary will act as a nodal point for communication between officials and management of 'IMPACT INDIA FOUNDATION'.
- (g) To purchase and sale property on behalf of society.
- (h) To file and contest suits in the court for the society.
- (i) To file contest Bank account jointly with Treasure and President.
- (j) To prepare project scheme to be adopted by the society.
- (k) To get project/ Scheme approved by the government and other bodies.
- (l) To represent and act one behalf of the society in government department CAPART, NABADA and other bodies.

- (m) To arrange fund for the society.
- (n) To prepare the account Book,
- (o) To keep the account for the inspection of the members.
- (p) The Secretary will evolve and monitor a system of annual performance appraisals confidential character rolls of every officers and supporting staff.

- (r) In emérgency, The secretary can expense upto Rs. 5000/- without prior order but it be made allowed in next meeting with written cause and evidence.

**(IV) JOINT-SECRETARY:-**


The Joint Secretary will be vested of all the powers of the Secretary in the absence of the Secretary, else will be guided by the president for his works as delegated by the Secretary .


**(V) TREASURER**


- (i) Treasurer of the society will be responsible for the fund management of the society

8. Power and functions of general body :-


- (i) Election of members of executive body including office bearers.

- (vii) To authorized the secretary to sale purchase the property.


9. General body meetings:-


- (i) There will be annual meeting of the general body and special meetings of general body can be called anytime of the year.
- (ii) General body meetings should be called by the secretary 3 days of the written.
- (iii) Application of 1/3 members with their signature and to pies/ points of discussion. If the secretary does not call the meetings with 30 days then the applicant members will have right to take decision.
- (iv) Quorum; Quorum for the all meetings of the general body will be one more than the half of total members (50%+1).
- (v) Notice of meeting:- (A) notice of all meetings of general body will be given at least 10 days before the meeting. (B). Notice of meetings can be given be registered post or getting signature of the member on register.

10. Meetings of Executive Committee:-

Executive committee will meet in the interval of every three month. Executive committee can pass resolution relating to the society by 2/3 majority of the members present. The executive committee in their meeting will elect office bearers of the society from executive members. In case of any emergency meeting information will be given 48 hrs before.
